RESOLUTION NO. 71

BOARD OF DIRECTORS OF THE CONGRESS VALLEY WATER DISTRICT

A RESOLUTION ADOPTING MODERATE WATER SHORTAGE WATER USE REGULATIONS, PURSUANT TO NAPA MUNICIPAL CODE SECTION 13.10.040, SUBDIVISION A

WHEREAS, on May 4, 2021, the Napa City Council declared a moderate water shortage exists after a second consecutive dry winter and that a 15% community-wide demand reduction is needed to maintain water supply reliability;

WHEREAS, the Napa City Council further resolved that each customer shall comply with the prohibitions and limits set forth in Napa Municipal Code section 13.10.050;

WHEREAS, on July 20, 2021, the Napa City Council further supplemented the moderate water shortage regulations to achieve 20% community-wide demand reduction, which would require each customer to comply with prohibitions and limits set forth in Ordinance 02021-006 (Ordinance of the City Council of the City of Napa, State of California, Amending Napa Municipal Code Chapters 13.04 and 13.10 Regarding Moderate Water Shortage Regulations);

WHEREAS, Napa Municipal Code section 13.10.040, subdivision A, requires the Congress Valley Water District (the "District"), to enact and enforce water use regulations during a declared moderate water shortage identical to those water use regulations in Chapter 13.10 of the Napa Municipal Code; and

WHEREAS, the District is also bound by Section 9 of the Water Supply Contract between the City of Napa and the District to enact and enforce water conservation programs substantially equivalent to those water conservation programs adopted by the City of Napa;

NOW THEREFORE, the Board of Directors of the District hereby resolves as follows:

Section 1: All of the recitals set forth above are true and correct, and this Board of Directors hereby so finds and determines.

Section 2: The District hereby adopts and enacts the following water use prohibitions and limitations, pursuant to modified Napa Municipal Code section 13.10.055:

No person shall use water for outdoor irrigation at a property on a Prohibited Irrigation Day, as follows:

1. For each property with a street address ending in an even number, the Prohibited Irrigation Days are Saturday, Sunday, Tuesday, Wednesday, and

Friday (meaning outdoor irrigation is permitted only on Monday and Thursday).

- 2. For each property with a street address ending in an odd number, the Prohibited Irrigation Days are Saturday, Sunday, Monday, Wednesday, and Thursday (meaning outdoor irrigation is permitted only on Tuesday and Friday).
- 3. As an exception to the prohibitions specified in this subsection A, any person may use water on any day for any of the following:
 - a. Drip and micro-spray irrigation systems;
 - b. Hand watering with: (i) a container or (ii) a hose fitted with an attached shutoff nozzle or device that causes the hose to cease dispensing water immediately when not in use;
 - c. The limited operation of irrigation systems solely for testing. maintenance, or repair.

Section 3: This Resolution shall take effect from and after its adoption.
